Rental Application Cover Letter

Thank you for choosing **Pleasant Townhomes!** We take considerable amount of pleasure in providing quality housing to anyone that meets our qualifications. The management is committed to complying with all applicable laws including all Fair Housing Laws and prohibits discrimination based on race, color, national origin, religion, sex, familiar status, disability, age, sexual orientation, gender identity, or status as a student. Below is a list of minimum requirements and qualification that management utilizes to determine the eligibility of each applicant. The information below is provided to give an understanding of the qualifying procedure. **All of the items below are necessary to assure the proper review of the application package.**

- 1. **Application:** a signed and **fully** completed application for each adult over the age of 18.
- 2. Deposits and Fees: A refundable \$1,475.00 security/damage deposit.
- 3. **Credit Report:** a credit report will be obtained for all applicants from the past 24 months of credit history. Negative credit information will be reviewed as to the age of the account, account type, and the extensiveness of the negative debt (excluding student loans and medical). Outstanding judgments or liens may not be accepted and if accepted will result in an additional security deposit amount equal to or larger than one month's rent or possible denial. Any "open" bankruptcy is an automatic denial. International applicants may present a valid passport or other valid government identification in lieu of credit reporting and the U.S. International applicant must also complete a Supplement Non-Citizen Application and provide copies of all required documents.
- 4. **Rental History:** Delinquent rental payments and/or failure to fulfill terms on prior lease are grounds for denial. First time renters may be required an additional deposit. Must have six (6) months verifiable and positive rental history. Roommates must qualify individually in all areas except income.
- 5. **Employment History:** Current and/or previous employment for six (6) month is required. Additional deposit may be required if employment history is less than six (6) months. Full-time students may have guarantors.
- 6. **Income Verification:** Applicant(s) must supply management with written verification, two current paycheck stubs, or six (6) months Bank Statements.
- 7. **Income Requirements:** Applicant(s) must earn three (3) times the amount of the monthly rent.
- 8. **Identification:** A copy of your current valid driver's license or state ID card and social security card is required with each applicant.
- 9. **Maximum Occupancy:** Two (2) people per bedroom. (Exception a child under 12 month of age)
- 10. **Electric, Gas, Water, and Trash Service:** Proof of electric, gas, water, and trash service will be required before move-in.
- 11. Pet Restrictions: Two (2) Pets are allowed according to breed (no aggressive breeds). 50 lb. weight limit (full grown).
 - a. **Pet Deposit:** Variable carpet pet damage deposit dependent on age and condition of existing carpet (refundable if carpet not damaged by pet. \$300 is non-refundable)
- 12. **Criminal Background Check:** A criminal background check will be done on each applicant. Record of any felony, drug related or violent criminal offenses will be grounds for denial.
- 13. **Inspection of Current Housing:** A brief inspection of your current housing will be requested in order to insure that you take care of other people's property. Denial of inspection or evidence of damage above and beyond normal wear and tear will be grounds for denial.
- 14. **Guarantor:** First time renters, students and retired persons may utilize a guarantor. The guarantor income must be six (6) times their rent/mortgage and the application's rent amount combined.
- 15. Renter Insurance: A minimum of \$100,000 property liability insurance is required before move in.
